# Why we do it 🦅

We dream rural palliative care might someday:

- allow last days to hours to be just a little bit easier
- support us to better manage end of life issues as they arise
- guide us to be better informed

Wheatland & Area Hospice Society recognizes that most patients would prefer to stay in their home for as long as possible, perhaps transferring to hospice or hospital within days of death. Occasionally both patient and family would prefer the entire end of life journey to be at home.

> 95% Time spent by a palliative patient outside of medical system until death

WAHS is here to support each individual's wishes throughout their palliative journey. We have an active Outreach Program throughout Wheatland County and area with caring, trained volunteers to help with respite and navigation. We think of ourselves as a "hospice without walls" for now. We also recognize that sometimes family and friends can burn out, or travel requirements to access hospice care in Calgary are too great. Or perhaps, a patient's home might just not be the right set-up for end of life care. In this case, our own rural hospice located in Strathmore will be just the answer.

Lastly, future provincial health planning will be redirecting palliative funding away from acute care beds and towards care in our own communities. There will be an enormous amount of dependence on volunteers and family for this strategy to be successful.

- Let's remember end of life care doesn't have to happen to us to be important to us.
- Let's support our community as we move forward with government funders towards new hospice palliative care models.
- Let's recognize the incredible work of WAHS's volunteers involved in palliative outreach services, fundraising, program and policy development, and community/stakeholder engagement.
- Let's continue our collaboration with Wheatland Housing Management Body to build a compassionate and groundbreaking rural hospice near Kinsmen Park, Strathmore.

In and out of covid restrictions, our society has nonetheless been working hard to get things done this past year.


