
Wheatland & Area Hospice Society 5th anniversary project is a journal to record precious family memories and reflections.

FARMING FOR HOSPICE

Goal 3,000,000 1,920,000 Raised

Once again a HUGE THANK YOU to Nutrien Carseland Nitrogen Operations for providing us a quarter section of land for the 2021 crop year. Wheatland & Area Hospice Society will source all crop input costs (seed, chemical, fertilizer, insurance, etc.) through sponsored inputs and acre donations. The crop will be seeded with 45CS canola seed from Pioneer.

OPPORTUNITY TO PARTICIPATE - DONATE TO COVER INPUT COSTS:

Input costs are estimated at \$300/acre and donations can be made in any amount. Individuals are invited to sponsor as many acres as they wish, and charitable receipts will be issued for all gifts.

A number of local area farmers and various agricultural businesses have generously donated the farming operations necessary (i.e., seeding, spraying, swathing, harvesting, etc.) All monies from sale of the crop, go towards Wheatland & Area Hospice's goal of building a local hospice.

Volunteer in Profile—Dianne Cammaert-Palliative Navigator

I graduated from the nursing program at the Misericordia Hospital in Edmonton in the mid '70's. My career started in Emergency room, then moved to general practice in Drumheller. This was motivated by the need to be nearer my beau and the mountains. In the late 1970's the Home Care Program came to be and this became my foray into community health. Over time I drifted down the hall to Public Health Nursing with short interludes in Long Term Care and Growing Opportunities(a Canada Prenatal Nutrition Program). Community Nursing was enjoyable for me as I got to meet the clients on their turf and got to know the communities throughout the County of Wheatland.

Pat & I met in Edmonton while he was studying Agriculture. We have 3 adult children who all live within an hour and a half from the farm. 2 Grandchildren and 2 adopted grandkids keep us in smiles and some sort of bendy shape. Hiking, Camping and skiing are some of the things we enjoy doing with them.

When I retired from formal nursing practice, I was concerned that I'd miss the community connection. So a natural choice was to volunteer with the programs that I'd worked with before. My connection with Hospice came by way of an invitation from Dr. McNeely. My interest was piqued by the fact that we could have a Hospice Facility in our own community. Surely, I thought, this is work that needs to be done. I enjoy the connection with people most. Having aging parents taught me that it's often difficult for them to find resources they need to care for themselves. When someone is palliative, this can be true also. It is compounded by the fact that it's a very emotional time, they don't know what to expect, what dying looks like and sometimes they might wonder who their supports will be. My role is to meet with them and help them identify what they need on their journey and offer help in connecting with formal and informal resources.

Virtual Hike for Hospice



Introduction

The goal of this newsletter is to provide up-to-date, accurate information related to the development of a new community seniors' living facility for Strathmore and the entire Wheatland County. This information will be truthful and accurate and comes from the people who know the information and the steps that are involved with a development such as this.

Where We Are At:

- A Seniors' Housing Needs Assessment and Business Case was completed in August of 2019. This report, completed by Gordon & Associates, demonstrated the need for additional seniors' housing in the region. Based on the recommended number of units needed in the region, there will be an increase in the level of care provided by the Foundation. We are designing for 165 new state-of-the-art seniors' living units.
- We have completed an application for Supportive Living Funding from Alberta Health Services. Feedback is expected on this application in February/March.
- There have been five Community Video Sessions, with excellent community involvement. These sessions provided project information, demonstrated a sincere commitment to the project by the WHMB and the community, and resulted in a strong foundation on which we can build a great project.
- Working with the Building Committee, we have reviewed several project locations and are working to establish one site for the new facility.
- Berry Architecture has begun to develop a schematic design of the project based on the information gathered to date.

Next Steps:

- Identify and negotiate purchase agreement of the site. We hope to begin this process by the end of January and be able to announce the selected site mid-February.
- Complete Schematic Design; this is expected to be completed at the end of January.
- Develop Project Budget; target is mid-February.
- Research Funding Opportunities and Partnerships; this is ongoing.
